**EXECUTIVE SESSION** 

Motion was made by Reser, seconded by Bishop, to enter into a 30 minute executive session for non-elected personnel, with the City Attorney present, for the purpose of discussing matters of non-elected personnel because if this matter were discussed in open session it might invade the privacy of those discussed. Council entered into executive session at 7:10pm to reconvene at 7:40pm.

Council reconvened at 7:40pm.

ADMIN COMMITTEE ORD #1055

Bishop presented Ordinance Number 1055 for approval. Motion was made by Bishop, seconded by Reser, to approve Ordinance Number 1055, authorizing the imposition of a three-fourths of one percent (.75%) city retailers' sales tax, in addition to the one percent (1.00%) tax currently levied within the City of Yates Center, KS, for the use in public infrastructure projects, including buildings, and economic development. Motion carried unanimously.

**DOLLAR GENERAL TAX INCENTIVE** 

Motion was made by Bishop, seconded by Reser, to approve the continuing tax credits for JG&K Enterprises (d/b/a Dollar General), in the amount of \$2,988.82. Motion carried unanimously.

**SAFETY COMMITTEE** 

Stuber congratulated the police department on another drug bust.

**PUBLIC WORKS COMMITTEE** 

Discussion was held on what to include in city wide clean-up day. It was the consensus of the Council to leave things the same but to stress to residents that if items were not sorted they would not be picked up. Hegwald to put an ad in the newspaper stating exact rules.

**ONE-CALL** 

After discussion on the one-call program it was the consensus of the Council to table the decision for two more weeks.

Motion was made by Hudlin, seconded by Black, to purchase an ADA lift chair from Recreation Supply Company not to exceed \$4000.00. Motion carried unanimously.

RV PARK INFO BOARD

Motion was made by Black, seconded by Hudlin, to purchase an information board for South Owl Lake RV Park from Upbeat for \$950.00. Funds to be taken from Special Recreation Facilities. Motion carried unanimously.

MAYOR COMMENTS

Mayor Wilhite had no comments.

**CLAIMS & VOUCHERS** 

Motion was made by Bishop, seconded by Stuber, to pay the claims and vouchers in the amount of \$113,545.62. Motion carried unanimously.
