



**YATES CENTER CITY COUNCIL MEETING
SPECIAL MEETING – DECEMBER 11, 2013**

City Council met in special session on Wednesday, December 11, 2013, at 6:15pm at city hall. Mayor Weber called the meeting to order at the request of council members Randall, Jones, Bishop, Black, Day, and Bishop. Absent were Reser and Stuber. Also present was City Clerk Becky Boice.

RESCHEDULE 12-23-13 MEETING

Motion was made by Randall, seconded by Bishop, to move the regular scheduled council meeting from December 23 to December 30. Motion carried unanimously. This allows council to meet the budget amendment hearing time line without having to have another special meeting.

HEATER FOR LIBRARY

Weber said he had been contacted by Librarian Janice Jones requesting help to pay for a new heater or repair the old one. The library does not have the funds to do either and are not able to be open but a couple of hours a day due to the cold weather.

Motion was made by Black, seconded by Randall, to waive the bid policy to allow the heater to be replaced or repaired as soon as possible. Motion carried unanimously.


