HEALTH INSIGHT TREADMILL

Black presented several proposals from Carla Green on the repair or replacement of a treadmill at Health Insight. Motion was made by Black, seconded by Stuber, to replace the motor and belt on the treadmill for \$589.98 and to have Hegwald install the parts. Motion carried unanimously.

SAFETY COMMITTEE BERT'S CMB SUSPENSION

Randall informed Council that Chief Kee had suspended Bert's Tavern's cereal malt beverage license for six days for allowing consumption of beer on a Sunday. Mr. Splechter has the right to request a hearing.

PUBLIC WORKS COMMITTEE STORM DRAIN RURAL FIRE BARN

Hegwald discussed with Council the need for a storm drain by the new rural fire barn. It was the consensus of the Council to go ahead with the work.

PINK WATER

Beecher reported the water department had a chemical pump malfunction allowing extra potassium in the water turning it pink. The EPA does not regulate potassium and the water is safe to drink.

BACKWASH PROJECT

Beecher reported parts for the backwash line project are starting to arrive.

Other items discussed included:

- a switch on the generator at the sewer plant needing repaired
- the mixer at the sewer plant needing replaced

MIXER AT SEWER PLANT

Motion was made by Beecher, seconded by Weber, To replace the mixer at the sewer plant, not to exceed \$4500 with the funds to come out of the Sewer Utility Reserve Fund. Motion carried unanimously.

SCHOOL SIGNS

Hegwald informed Council that the school has purchased "State Champion" signs. It was the consensus of the Council to put the signs by the "Welcome to Yates Center" signs. Hegwald said he would be checking with KDOT for permission to put the signs up.

KDHE BACKWASH PERMIT

Mayor Wilhite requested permission to sign a permit from KDHE for the additional work to be performed in changing over from using the water storage tank just outside of the operational building to using water directly from the high service pumps, distribution system and/or the elevated tank from uptown. Motion was made by Reser, seconded by Weber, to give Mayor Wilhite permission to sign the permit. Motion carried unanimously.

ADMINISTRATIVE COMMITTEE RR PROPERY MOWING

Peebles reported that she thought more investigating needed to be done on the ownership of the railroad property. Motion was made by Stuber, seconded by Weber, to request Peebles do more research on the matter. Motion carried unanimously.

CITY VEHICLE POLICY

Reser presented a written policy for procedures and use of the 2004 Chevrolet pick-up and the former Number 2 police car. Motion was made by Reser, seconded by Beecher to accept the policy as written and to place the policy in the policy manual. Motion carried unanimously.

DRUMLINE @ YC DAYS

Boice presented a request from Katy Ludwig, Executive Director of the Woodson County Chamber of Commerce to sponsor the Topeka Drumline for Yates Center Days. Motion was made by Reser, seconded by Bishop, to sponsor the Topeka Drumline for Yates Center Days. Motion carried unanimously with money to come from the Economic Development Fund.

LEGION RIDERS CMB APPLICATION

Motion was made by Bishop, seconded by Beecher, to approve the 2011 Cereal Malt Beverage Application for the American Legion Riders — Post #13. Motion carried with Reser abstaining.

EXECUTIVE SESSION

Motion was made by Reser, seconded by Bishop, to enter into an executive session for 10 minutes for trade secrets with Boice and Peebles present. Motion carried unanimously, and Council entered into executive session at 7:50pm.
