SAFETY
ANIMAL CONTROL OFFICER

Randall informed council that Heather Bauer, the Animal Control Officer for the city has resigned. Howard Randall is filling in until the position can be advertised. Motion was made by Reser, seconded by Beecher, to advertise for the position of Animal Control Officer. Motion carried unanimously. Applications due by 5:00pm, Monday, February 2.

EXECUTIVE SESSION

Motion was made by Reser, seconded by Stuber, to enter into a 15 minute executive session for non-elected personnel with the city attorney present, because if this matter were discussed in open session it might invade the privacy of those discussed. Motion carried unanimously. Council entered into executive session at 7:29pm, to reconvene at 7:44pm.

PUBLIC WORKS
WATER RATE INCREASE

Discussion was held on the need to increase the water rates. Motion was made by Beecher, seconded by Stuber to increase the water rates by 1 ½%. Motion carried unanimously.

SEWER RATE INCREASE

Discussion was held on the need to increase the sewer rates. Motion was made by Beecher, seconded by Stuber, to increase the sewer rates by 1 $\frac{1}{2}$ %. Motion carried unanimously.

RAW WATER SALES S OWL LAKE

Boone explained to council he had been approached by a contractor bidding on the overpass project east of town wanting to buy bulk water. Boone suggested selling raw water out of South Owl Lake at a reduced rate. After discussion involving how this would work with the Community Fisheries Assistance Program, and the potential cost of repairing the road due to heavy truck traffic other options were discussed. It was the consensus of the council for Boone to inform the contractor the city would sell bulk water at \$10.00 per thousand if he was interested and possibly install a hydrant on the water line east of town.

Motion was made by Beecher, seconded by Stuber, to enter into a 15 minute executive session for non-elected personnel with the city attorney present, because if this matter were discussed in open session it might invade the privacy of those discussed. COLA RAISES

It was the consensus of the council to table discussion on employee cost of living raises until the next meeting.

Motion was made by Day, seconded by Beecher, to pay the claims and vouchers in the amount of \$75,601.84. Motion carried unanimously.
