

**YATES CENTER CITY COUNCIL MINUTES  
MARCH 30, 2015**

The Yates Center City Council met in regular session on Monday, March 30, 2015, at 7:00pm at City Hall. The Pledge of Allegiance was recited.

Mayor Weber called the meeting to order. Roll call as follows: Reser, Randall, Day, Bishop, and Jones. Absent: Beecher, Black, and Stuber. Other city officials present included: City Attorney Tom Mikulka, Water Superintendent Eric Boone, Street Superintendent Randy Hegwald, and City Clerk Becky Boice.

**AGENDA AMENDED & APPROVED**

Jones added Justin Morrison, with Kansas Department Of Wildlife, Parks, and Tourism to discuss the milfoil at the Yates Center Reservoir.

Reser added discussion on a concrete saw for the street department.

Motion was made by Day, seconded by Randall, to approve the agenda as amended. Motion carried unanimously.

**MINUTES APPROVED**

Motion was made by Day, seconded by Bishop, to approve the minutes from the March 16, 2015, meeting as printed. Motion carried unanimously.

Motion was made by Day, seconded by Bishop, to approve the minutes of the March 25, 2015, special meeting as printed. Motion carried unanimously.

**PV MINUTES APPROVED**

Motion was made by Day, seconded by Randall, to approve the Yates Center Housing Authority minutes from January 14, 2015, as printed. Motion carried unanimously.

Motion was made by Day, seconded by Bishop, to approve the Yates Center Housing Authority minutes from February 11, 2015, as printed. Motion carried unanimously.

**CASA PROCLAMATION**

Aimee Daniels and other CASA representatives were present to request that the City of Yates Center proclaim April as Child Abuse Prevention & Awareness Month. Motion was made by Randall, seconded by Day, to authorize Mayor Weber to sign the proclamation as presented. Motion carried unanimously.

**JUSTIN MORRISON**

Justin Morrison with the Kansas Department of Wildlife, Parks, and Tourism, gave a report on his recommendations for treating the milfoil at the Yates Center Reservoir.

**KDOT UPDATE**

Darrin Petrowsky with the Kansas Department of Transportation, was present to give an update on highway projects in the area. He also answered questions on the overpass project east of Yates Center.

**CITY ATTORNEY  
COMMITTEE REPORTS  
ADMINISTRATIVE – CITY CAR**

Mikulka had nothing to report.

Day presented the one bid received for the 2005 Ford Crown Vic. Motion was made by Day, seconded by Bishop, to accept the bid of \$2000 from Amy Kirkpatrick. Motion carried unanimously.

**SAFETY  
AGENDAS**

Weber reported that the police department would no longer be delivering council agendas. The agendas will be e-mailed with copies to be available at the meeting.

**PUBLIC WORKS  
DAM INSPECTION**

A brief discussion was held on the dam inspection required for the Yates Center Reservoir. The matter was removed from the agenda until a later date.

**MCCONAGHIE WATER LINE**

Discussion was held on the size of water line to install on North Hurt to provide city water to a house recently purchased by Pat and Amy McConaghie. Discussion was also held to decide if the city should install a fire hydrant at the same time as the water line. Boone to supply prices for the proposed project for a 4" line with a hydrant and a 2" line without a hydrant. Weber wanted to assure McConaghies' that the city will supply the water, but wanted to decide on the size of the line. The fire hydrant being installed was requested by members of the council and fire department.

A special meeting to be scheduled as soon as Boone supplied the information.

**CONCRETE SAW**

Reser provided three bids for a concrete saw for the street department. After discussion, it was the consensus of the council to have the street department use the water department's concrete saw for now.

**PARKS & PUBLIC LANDS  
POOL PREP SPECS**

Jones provided the pool preparation bid specifications to review. Motion was made by Jones, seconded by Bishop, to solicit bids for the pool preparation specifications as presented. Motion carried unanimously. Sealed bids due by Friday, April 10 at 5:00pm. The city to reserve the right to reject any and all bids.

**MAYOR COMMENTS**


Weber reminded council to request a special meeting be called as soon as possible to review prices for the water line project on North Hurt.
