Day informed council that a dividend check had been received for \$11,969.29 from Employers Mutual Casualty Company.

WORK ORDERS

Beecher tabled discussion on work orders until the new committee appointments are made.

ST DEPT SURPLUS EQUIP

Beecher presented a request from Hegwald to advertise for sale surplus equipment from the street department. It included tanks, roller, tractor, and propane bottles. Motion was made by Beecher, seconded by Day, to advertise the equipment for sale by sealed bids due 5:00pm, Friday, May 22. Hegwald to advertise in the Yates Center News and on Craigslist. The city to reserve the right to refuse any or all bids.

SPLECHTER PROPERTY

Reser asked Boone for an update on the erosion problem with the Ed Splechter property adjoining the sewer plant. Boone reported they were waiting for Mr. Splechter to remove barbed wire fence he wanted to keep. It was the consensus of the council to have the project completed as soon as possible.

Boone informed council that he was having problems with the SCADA system that runs the pumps at the lake. He will notify them as soon as he has more information.

EXECUTIVE SESSION

Motion was made by Beecher, seconded by Bishop, to enter into a 15 minute executive session for attorney/ client privilege for the purpose of discussing with the city attorney matters of a confidential character and which is private. The mayor, city attorney, water superintendent and city clerk to be present. Motion carried unanimously and council entered into executive session at 8:57pm to reconvene at 9:12pm.

Council reconvened at 9:12pm.

PARKS & PUBLIC LANDS POOL PAINT

Jones reported a problem with the new paint flaking off the bottom of the pool. The street department to scrape the paint off and repaint the areas repaired as soon as possible.

POOL DONATION

Council once again expressed their appreciation to John Danler and the Yates Center Branch Bank for their donation towards the pool improvements.

CDBG UPDATE

Jones and Hegwald updated council on the plans for the proposed improvements at Lincoln Park, South Owl Lake, and the ball fields. Council looked over prints from BG Consultants. It was the consensus of the council to proceed with the CDBG funding process.

DOG PICKUP STATIONS

Jones reported that city hall has received numerous complaints on people letting their dogs run loose and not picking up after them at Delay Stadium and Lincoln Park. Motion was made by Jones, seconded by Bishop, to purchase two dogipot stations to be placed at Delay Stadium and Lincoln Park from Kay Park Recreation for \$276.00 each. Motion carried with Randall voting no. The city does have an ordinance in place where tickets can be issued for people not picking up after their dogs.
