The Yates Center City Council met in regular session on Monday, September 19, 2011 at 7:00pm at City Hall. The Pledge of Allegiance was recited.

Bishop presented an estimate from Jayhawk Lumber, Glass & Rental for a new front door for City Hall. Superior Building Supply had been contacted but would have had to purchase the door from Jayhawk Lumber. Motion was made by Bishop, seconded by Randall, to purchase a new front door for City Hall from Jayhawk Lumber in the amount of \$1096.35. Motion carried unanimously.

A possible date for next years Mardi Grass was briefly discussed. It was the consensus of the Council to wait until the Masons had a chance to discuss their options.

Motion was made by Bishop, seconded by Reser, to enter into an executive session for 30 minutes, with Peebles and Boice, for the purpose of discussing matters of non-elected personnel because if this matter were discussed in open it might invade the privacy of those discussed. The open meeting will reconvene at 7:40pm. Motion carried with Black voting no.

Council reconvened at 7:40pm. Motion was made by Reser, seconded by Bishop to extend the executive session until 8:00pm with the same people present. Motion carried unanimously.

Therefore, it is in the best fiscal interest of the city to eliminate the Municipal Court Clerk/Office Assistant position. The duties currently performed in that position will be assumed by the other office staff. Motion was made by Reser, seconded by Randall, to eliminate the position effective immediately, with a severance package to be offered. Motion carried with Bishop and Black abstaining.

Motion was made by Reser, seconded by Bishop, to pay the claims and vouchers in the amount of \$44719.32. Motion carried unanimously.
