STREET DEPT SEASONAL WORKER

Motion was made Randall, seconded by Reser, to give the public works committee the authority to interview and hire a seasonal street department employee. Motion carried unanimously.

CHAIN LINK FENCE

Randall informed council he had been approached about selling chain link fencing being stored behind the water plant. He had checked with city departments to see if anyone could use it and the recreation commission will be taking it.

BEDENBENDER RAISE

Randall informed council that William Bedenbender had completed his 90 day probation with the water/waste water department. Motion was made by Randall, seconded by Reser, to give Bedenbender a .50 per hour raise, effective next pay period. Motion carried unanimously.

FAIRGROUND METER

Boone reported that the large water meter at the fairgrounds needs to be replaced. Motion was made by Randall, seconded by Beecher, to allow Boone to purchase the meter and needed parts not to exceed 1900.00. Motion carried unanimously.

Spoon informed council that the county was putting 20 loads of gravel on roads at the ballfield.

Hegwald is checking with Westar to get a cost analysis for security lighting at the ballfield.

Randall informed council that six returning life guards and four new life guards have been hired. Guards needing certifications will be taking classes this week.

Motion was made by Reser, seconded by Day, to pay the claims and vouchers in the amount of \$37,664.78.
