It was the consensus of the council to have another budget workshop with Bob Agler and Christie Miller. Boice to check on available dates.

Motion was made by Bishop, seconded by Stuber, to enter into a 20 minute executive session for the purpose of discussing matters of non-elected personnel because if this matter were discussed in open session it might invade the privacy of those discussed. Bishop announced the safety committee would be having a meeting with the date and time to be determined with the newspaper to be notified as soon as possible.

Motion was made by Bishop, seconded by Beecher, to raise the volunteer fire department's meeting rate and run rate. After discussion Bishop rescinded his motion, and Beecher rescinded his second. The matter to be discussed at the next budget workshop.

Randall tabled the work order discussion for two weeks.

Discussion was held on the proposed water plant improvements. It was the consensus of the council to not attend an upcoming KIAC meeting to be eligible for this year's round of CDBG funding.

Randall announced the public works committee would be having a meeting with the date and time to be determined with the newspaper to be notified as soon as possible.

Discussion was held on the proposed contract with Paddock Pools to inspect the pool at the end of the season. Motion was made by Day, seconded by Bishop, to have the mayor sign the contract for Paddock Pools to inspect the pool for \$6500. Motion carried unanimously. Mikulka to prepare the contract.

Day presented an agreement between the City and KWIKOM for an internet hotspot in the Lincoln Park/swimming pool area. After discussion, it was the consensus of the council to not sign the agreement and negotiate it with KWIKOM when the contract for the equipment on the water tower is due for renewal.

Day presented one sealed bid for the white tent advertised for sale. Motion was made by Day, seconded by Bishop, to sell the tent to YC Ventures for \$800. Motion carried unanimously.
