

**YATES CENTER CITY COUNCIL MINUTES  
JANUARY 7, 2013**

The Yates Center city council met in regular session on Monday, January 7, 2013 at city hall. The Pledge of Allegiance was recited.

Mayor Wilhite called the meeting to order at 7:03pm. Roll call as follows: Reser, Randall, Weber, Beecher, Black, Stuber, and Bishop. Absent: Day. Other city officials present included City Attorney Tom Mikulka, Deputy Police Chief Ken Leedy, and City Clerk Becky Boice.
