YATES CENTER CITY COUNCIL MINUTES APRIL 2, 2018

Yates Center City Council met in regular session on Monday, April 2, 2018, at City Hall. The Pledge of Allegiance was recited.

Mayor Weber called the meeting to order at 7:00pm. Roll call as follows: Reser, Randall, Wiehn, Beecher, Spoon, and Shaffer. Absent: Cathcard and Jones.

Other city officials present included: City Attorney Brian Duncan, Water Superintendent Eric Boone, Chief of Police Doug Smoot, Deputy Chief of Police Ken Leedy, Street Superintendent Randy Hegwald, and City Clerk Becky Boice.

AGENDA AMENDED & APPROVED

Wiehn moved opening the ballfield lighting project bids from the parks and public lands committee to the top of the agenda.

Beecher removed wages under public works and added a 30 minute executive session for non-elected personnel.

Weber added discussion on dams at the Yates Center Reservoir under the parks and public lands committee.

Motion was made by Reser, seconded by Beecher, to approve the agenda as amended. Motion carried unanimously.

MINUTES APPROVED

Motion was made by Reser, seconded by Wiehn, to approve the minutes of the March 19, 2018, meeting as printed. Motion carried with Spoon abstaining.

CHAMBER CHRISTMAS LIGHTS

Carla Green, Marla Newman, and Laura Sterling, representatives of the Woodson County Chamber were present to discuss Christmas lights and fundraising options.

The administrative committee to meet and recommend an option to go with on Christmas lights and notify the chamber.

CASA PROCLAMATION

Representatives from CASA were present with a proclamation for Child Abuse Prevention Month.

Motion was made by Reser, seconded by Wiehn, for Mayor Weber to proclaim April 2018 as Child Abuse Prevention Month. Motion carried unanimously.

BALLFIELD LIGHTS

Wiehn opened the only bid received for the ballfield lighting project:

J&C Electrical Solutions, LLC - \$18,339.42

Council discussed possible options on helping to fund the project.

Motion was made by Wiehn, seconded by Reser, to accept the bid from J&C Electrical Solutions not to exceed \$20,000.00. Motion carried unanimously.

Motion was made by Reser, seconded by Beecher, to approve Ordinance Number 1106 as presented. Motion carried unanimously.

Motion was made by Spoon, seconded by Beecher, to adopt Ordinance Number 1107 as presented. Motion carried

unanimously.

PD UPDATE Spoon informed council she did not have an update on the

police department right now, but would let them know when

more information was available.

PUBLIC WORKS Duncan informed council that the easements on the South Hwy **S HWY 75 SEWER PROJECT**

75 project have been filed and Wilson and Company were ready

to solicit bids for the project.

Motion was made by Randall, seconded by Beecher, to allow Wilson & Company to start the bid process. Motion carried

unanimously.

Council asked Boice to check into if the budget would need to be amended to cover the raises.

Motion was made by Wiehn, seconded by Reser, to hire Dallas Knowles for the seasonal parks worker position at \$9.75

per hour. Motion carried unanimously.

It was the consensus of the council to let Knowles use street department tools and drive the Chevy pick-up when available.

POOL FIBERGLASS REPAIR

It was the consensus of the council to have the street department do the fiberglass repair at the pool along with

any painting in the pool.

SEDIMENT DAMS

Motion was made by Wiehn, seconded by Reser, to not include the sediment dams at the Yates Center Reservoir on the city's insurance policy. Motion carried unanimously.

SOWL RR

Wiehn announced that the delivery date on the new restroom

for South Owl Lake was June 5.

carried unanimously.

HOUSING AUTHORITY

Motion was made by Reser, seconded by Wiehn, to pay the claims and vouchers in the amount of \$101,244.00. Motion

carried unanimously.
