SAFETY ORDINANCE NUMBER 1114

Duncan presented Ordinance Number 1114 for approval; AN ORDINANCE ESTABLISHING ENFORCEMENT AND FINES FOR DEPOSITING GRASS, YARD CLIPPINGS OR LEAVES ON ANY STREET OR ALLEY.

Motion was made by Spoon, seconded by Shaffer, to adopt Ordinance Number 1114 as presented. Motion carried unanimously.

PUBLIC WORKS CLOTHING ALLOWANCE

Discussion was held on allowing the public works employees a \$300 per year clothing allowance for pants and boots.

	Mayor Weber cast the tie-breaking vote of no and the motion did not pass.
PARKS & PUBLIC LANDS	Wiehn presented a letter from UMC wanting clarification on several items for the feasibility study being done at the pool.
	Council reviewed the items and came to a consensus on how they were to be handled.
FFL THANK YOU	On behalf of the Friends For Life Committee, Wiehn wanted to thank the public works employees for their help in getting ready for the cancer walk.
MAYOR COMMENTS	Weber stressed the importance to council of looking at the agenda as soon as it is received so if anyone has any questions or needs more information they can have it before council meeting.
CLAIMS & VOUCHERS	Motion was made by Reser, seconded by Randall, to pay the claims and vouchers in the amount of \$151,662.19. Motion carried unanimously.
