

**YATES CENTER CITY COUNCIL MINUTES
MARCH 18, 2013**

City Council met in regular session on Monday, March 18, 2013, at 7:00pm at City Hall. The Pledge Of Allegiance was recited.

Mayor Wilhite called the meeting to order. Roll call as follows: Reser, Randall, Day, Weber, Black, and Bishop. Absent: Stuber and Beecher. Other officials present included: City Attorney Tom Mikulka, Police Officer John Stimatze, Street Superintendent Randy Hegwald, Water Superintendent Eric Boone, and City Clerk Becky Boice.

AGENDA AMENDED & APPROVED

Randall amended the agenda to include accepting a bid for removal of the old radio tower on City Hall.

Weber amended the agenda to include a zoning concern, a new employee position, and alleys.

Motion was made by Weber, seconded by Bishop, to approve the agenda as amended. Motion carried unanimously.

Weber made one correction in the March 4 minutes. Motion was made by Weber, seconded by Bishop, to approve the minutes as corrected. Motion carried unanimously.

MAYOR COMMENTS

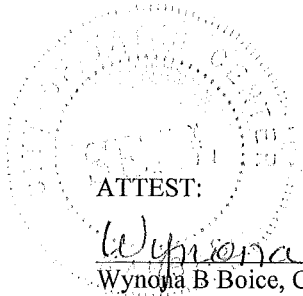
Mayor Wilhite did not have any comments.
