




- To adopt Ordinance Number 1083, pertaining to raising water rates and Ordinance Number 1084, pertaining to raising sewer rates.

- For discussion on proposed water line for Luke Galemore





**YATES CENTER CITY COUNCIL MINUTES  
OCTOBER 29, 2015 – SPECIAL MEETING**

Yates Center City Council met in special session at City Hall on Thursday, October 29, 2015, at 6:00pm to:

**ORDINANCE# 1083**

**ORDINANCE# 1084**

Motion was made by Day, seconded by Bishop, to adopt Ordinance Number 1084, AN ORDINANCE AMENDING USER CHARGE, SEWER UTILITY. Motion carried unanimously.

**GALEMORE WATER LINE**

It was the consensus of the council to handle Luke Galemore's proposed water line as other water lines outside of city limits have been handled.

**SPOON EXCUSED**


Spoon excused herself at 6:30pm.
