Motion was made by Day, seconded by Stuber, to approve the minutes of the November 7, 2016, council meeting as printed. Motion carried unanimously.

President of the Council Randall arrived at 7:07pm to preside over the meeting. Reser returned to his council seat.

CITY ATTORNEY

Duncan presented two oil rights division orders. Motion was made by Reser, seconded by Bishop, to give the city clerk authority to sign and return the oil rights division orders. Motion carried unanimously.

He also requested in the future anything regarding Prairie Villa to be brought to him before it is discussed at council meeting.

Discussion was held on the bid for cleaning the water sludge pond out. Motion was made by Randall, seconded by Stuber, to allow the city clerk to sign the bid/contract from Nutri-Ject Systems, Inc. for \$95,257.80 contingent on the city attorney's approval. Motion carried unanimously.

RESERVOIR DOWNSTREAM FLOW

Discussion was held on the water flow provided to property owners downstream at the Yates Center Reservoir. It was the consensus of the council to have Duncan review the original contracts with the land owners and provide a draft proposal for new contracts.
