AGENDA AMENDED & APPROVED

Motion was made by Wiehn, seconded by Randall, to write off an uncollectable account in the amount of \$56.07 and send in to the state set-off program uncollectable accounts in the amount of \$6,195.95. Motion carried unanimously.

SAFETY AXON TASER CAMERA

Kee presented a contract renewal from AXON Enterprise, Inc for license and evidence storage for the Taser cameras.

Motion was made by Bishop, seconded by Stuber, to have Kee sign the AXON contract for one year for \$895.50. Motion carried unanimously.

Weber reported on the meeting the safety committee had with the Woodson County Commissioners, sheriff, and head dispatcher on renewal of the dispatching contract due to expire on December 31.

Weber presented a contract for approval. Motion was made by Bishop, seconded by Spoon, to approve the one-year contract for \$20,000.00 paid to Woodson County for dispatching services, with negotiations for a new contract to start in the spring. Motion carried unanimously.

Motion was made by Bishop, seconded by Stuber, to enter into a 10 minute executive session with the city attorney for non-elected personnel because if this matter were discussed in open session it might invade the privacy of those discussed. Motion carried unanimously. Council entered into executive session at 7:53pm to reconvene at 8:03pm.

Council reconvened at 8:03pm.

Motion was made by Bishop, seconded by Stuber, to continue the executive session for 10 minutes with the same people for the same reason. Motion carried unanimously. Council entered into executive session at 8:04pm to reconvene at 8:14pm.

Council reconvened at 8:14pm.

Weber appointed Doug Smoot as police chief upon the retirement of Kee.

Motion was made by Randall, seconded by Bishop, to accept the mayor's appointment of Smoot as police chief contingent upon the city and Smoot signing a contract agreeing to a one-year probation period before January 18. Motion carried with Beecher, Wiehn, and Jones voting no.

Weber thanked council members Bishop and Stuber for all of their hard work and dedication to the city during their terms in office.

Motion was made by Wiehn, seconded by Bishop, to pay the claims and vouchers in the amount of \$75,810.58. Motion carried unanimously.

Motion was made by Bishop, seconded by Stuber, to adjourn. Motion carried unanimously and council adjourned at 8:25pm.
