Motion was made by Reser, seconded by Stewart, to award 4 Golden Stitches free water only for one year. Motion carried unanimously.

### **TOBACCO ON CITY PROPERTY**

Motion was made by Reser, to not allow tobacco in city owned buildings with public access. The motion died for lack of a second.

It was the consensus of the council to wait until the first of the year to enforce trimming the trees to a height of 18' over the streets to allow for road repair.

# PUBLIC WORKS ORDINANCE NUMBER 1149

Motion was made by Spoon, seconded by Cathcard, to raise street department worker Amos Cagle to 14.00 per hour. Motion carried unanimously.

**SEWER PLANT PART** 

Spoon informed council that the committee had given the authority for a repair part for the sewer plant to be purchased from Fluid Equipment in the amount of \$795.00.

**EXECUTIVE SESSION** 

Motion was made by Spoon, seconded by Reed, to enter into a five-minute executive session, in the council room, for the purpose of discussing with the city attorney matters of a confidential character. Motion carried unanimously. Council entered into executive session at 7:54pm to reconvene at 7:59pm.

Motion was made by Reed, seconded by Stewart, to adopt Ordinance Number 1150 as presented. Motion carried unanimously.

# **POOL PLAQUE**

# **ENGINEERING SERVICES**

Motion was made by Reed, seconded by Cathcard, to solicit bids for engineering services on the RV park expansion at South Owl Lake. Spoon to write the bid specifications, with the bids due back by August 13, 5:00pm. Motion carried unanimously.
