Yates Center City Council met in special session on Thursday, May 19, 2022, at 5:30pm, at City Hall for the purpose of adopting Resolution Number 346; TO POSE THE QUESTION FOR THE NOVEMBER 8, 2022, ELECTION BALLOT FOR THE CITY ELECTORS THAT: "SHALL THE CITY OF YATES CENTER, KANSAS, BE AUTHORIZED TO LEVY A THREE-FOURTHS OF ONE PERCENT (0.75%) CITY RETAILERS' SALES TAX WITHIN THE CITY OF YATES CENTER, KANSAS, AND TO USE THE REVENUE FROM THE ADDITIONAL TAX FOR PUBLIC INFRASTRUCTURE PROJECTS AND ECONOMIC DEVELOPMENT, SPECIFICALLY, ECONOMIC DEVELOPMENT (20%), SPECIAL HIGHWAY (20%), SPECIAL LAW AND EMERGENCY VEHICLES (25%), PARKS AND PUBLIC LANDS (7.5%), BALLFIELDS (7.5%), FIRE STATION (10%), AND THE SWIMMING POOL (10%), THE COLLECTION OF WHICH TO COMMENCE ON APRIL 1, 2023, OR AS SOON THEREAFTER AS PERMITTED BY LAW AND SHALL TERMINATE TEN (10) YEARS AFTER ITS COMMENCEMENT, PURSUANT UNDER K.S.A. 12-187 ET. SEQ. AND OTHER APPLICABLE STATE STATUTORY **PROVISIONS?**"

BE IT RESOLVED THAT THE CITY RECOGNIZES THIS TAX IS ALREADY LEVIED FOR ECONOMIC DEVELOPMENT (20%), SPECIAL HIGHWAY (20%), SPECIAL LAW AND EMERGENCY VEHICLES (25%), PARKS AND PUBLIC LANDS (7.5%), BALLFIELDS (7.5%), FIRE STATION (10%), AND THE SWIMMING POOL (10%), AND THAT THIS TAX IS A SALES TAX, RATHER THAN A PROPERTY TAX, THAT IS PAID BY ANYONE MAKING PURCHASES WITHIN THE CITY LIMITS FOR THE PURPOSE OF SUPPORTING THE FOREGOING REASONS.

Motion was made by Kee, seconded by Cavender, to adopt Resolution Number 354 as presented. Motion carried unanimously.
