NORTH & SOUTH PIPE GALLERIES

The parts and work needed at the North and South pipe galleries at the water plant were tabled until the August 15 meeting and it was requested that Eric Boone attempt to get bid specs from the engineers.

HYDRAULIC CYLINDER FOR SEWER TRUCK

Boone presented a quote from RED for the new cylinder. Boone and Ryther have made several contacts trying to get more quotes to no avail. Members of the sewer committee briefly discussed and approved the quote of \$574.45.

WATER SHUT OFF PROCEDURES
