Motion was made by Kee, seconded by Barney to raise the wage of Janet Thompson by \$2.00 per hour effective as of September 30, 2022. Motion carried unanimously.

SAFETY ARPA FUNDS-PURCHASING FIREARMS

Officer Strode contacted Taylor with SEKRPC to verify the ARPA Funds can be used to purchase of firearms and ammunition. She stated the funds were awarded to the City and can be used at the City's discretion.

Motion was made by Cathcard, seconded by Reed to allow purchase of weapons and ammunition. Motion carried unanimously.

LIVE 360 ON POLICE CELL PHONES

Since the city no longer has a water rescue team, the fire department would like to donate the trailer to the Kansas Firefighter's Honor Guard for fallen firefighter's funerals. This trailer was purchased with donations and no grant money.

Motion was made by Cathcard, seconded by Kee to donate the trailer to the Kansas Firefighter's Honor Guard. Motion carried unanimously.

City Attorney Duncan present Resolution No. 355; A resolution allowing Vaqueros Mexican Restaurant, LLC to operate a "Beer Garden" on October 8, 2022, on Rutledge Street between Main and State Streets and up to the curbing separating Rutledge Street and the Courthouse Lawn.
