CITY ATTORNEY	Duncan had nothing.
COMMITTEE REPORTS ADMINISTRATIVE SIGN FOR CITY HALL	A short discussion was held of the need for a sign at City Hall. Administrative committee should take this and get at least 3 bids. Cathcard will get the City Clerk the contact information of one company. Kee asked the Clerk to get the bids.
CHAMBER OF COMMERCE UPDATE	Barney stated the adopt a child applications have been sent out. Trunk or Treat will take place, but there is a meeting tomorrow about the parade.
CHRISTMAS LIGHT MEMORIAL FUND	A resident recently passed away and left some money to be used for City Christmas lights and decorations. Motion was made by Atkin, seconded by Kee to have the City Clerk create a line item in the General Fund for Christmas Lights Memorials. Motion carried unanimously. It was also noted that any one that would like to contribute to the fund to please contact the City office.
SAFETY JERRY SEDLACEK-WOODSON COUNTY	Mr. Sedlacek was present on behalf of Woodson County commissioners to talk about the possibility of combining law enforcement of the county and city. Cathcard stated when he joined the city council, he had the same thought, but after several years, does not think it's a good idea, which most of the council agreed. The City Police Chief has to answer to the Safety Committee and Council. Council was not sure who the Sheriff answers to, if anyone. Kee stated the city would have to abolish the police department and then have a contract with the Sheriff department to patrol the city. If it didn't work, then the city would have to hire personnel and purchase all vehicles and equipment. The mayor stated there are just too many variants at this time. Council agreed that the city is not interest at this point and need to look into growing both departments and work side by side together. Sedlacek also mentioned that the dispatch, starting in January 2025, will be under the direction of the commissioners, not the Sheriff.
PUBLIC WORKS ROAD OILER	The mayor and Ryther had discussed purchasing a road oiler with the county. At this time, there is no budget set aside for such a purchase.

PARKS & PUBLIC LANDS SOUTH OWL CAMPING DISCUSSION

Chief Strode presented a form that we could use similar to what Altamont uses. We need to get locks for both the water and electric and get a sign made stating that campers need to call City Hall if during business hours or the Sheriff's Department after hours, weekends or holidays. Also need to have check in and out times. The office and police department will work together to have everything in place at least by the first of the year.
