YATES CENTER CITY COUNCIL MINUTES OCTOBER 7, 2024

Yates Center City Council met in regular session on Monday, October 7, 2024, at City Hall. The Pledge of Allegiance was recited.

Mayor Weston called the meeting to order at 7:00 pm. Roll call as follows: Barney, Stewart, Shaffer, Cavender and Kee with one vacant position. Atkin and Cathcard were absent. Other city officials present included: City Attorney Brian Duncan, Police Chief Michael Strode, Police Officer Jake Morrison, Deputy City Clerk Kristen Cagle and City Clerk Janet Thompson.

AGENDA AMENDED & APPROVED

Kee added an Executive Session for non-elected personnel under Safety. Motion was made by Kee, seconded by Cavender to approve the amended agenda. Motion carried unanimously.

Motion was made by Kee, seconded by Barney, to approve the minutes of the September 16, 2024 meeting. Motion carried unanimously.

Mr. Scheer was here again to discuss the right of way south of his property. Weston went to look at the waterway where a street is platted. It does appear that the joining property's owner's cattle have made the waterway deeper and wider plus some erosion has occurred. Scheer has a fence on the north side of the waterway, but there is no fence on the south side of the waterway. Scheer is trying to clean some trees out and asked about some limbs that hang over the other property. Duncan said if it's just limbs, but the tree is on Scheer's property, the law says he has 3 feet for clean up.

Duncan will research whether or not the resident to the south needs to build a fence or if the city would be partially liable for some of the cost because of the right of way. This will be discussed at the next meeting on October 21, 2024.

Duncan had nothing.

The City Clerk presented the renewal for BCBS Insurance. It went up 12.22% this year. Last year it went down 13.32%, so when the budget was made, the amount from the previous year was left the same, so this increase is covered. Motion was made by Kee, seconded by Shaffer to approve the renewal. Motion carried unanimously.

Motion was made by Cavender, seconded by Barney to enter into a 10-minute executive session, in the Council room, with the Council, Mayor, City Attorney and Chief Strode present to discuss non-elected personnel. Motion carried unanimously and council entered into executive session at 7:39 pm to reconvene at 7:49 pm. Meeting called back into order at 7:46 pm.

PARKS & PUBLIC LANDS SOUTH OWL CAMPING DISCUSSION

Cagle and Thompson started the discussion how some campers will pull in, possibly occupying a reserved spot and not paying for their stay. Discussed only letting campers stay (especially down at the lake) only if they reserved. This still does not stop people from pulling in, staying and then leaving without paying. Chief Strode stated when he worked at Altamont they had locks on the utilities. Everyone thought this was a great idea. Strode and the clerks will work together to present a plan to get in place.
